Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('Listing Regulations') and the SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021 ('SBEB Regulations'), each as amended, this is to inform you that the Nomination and Remuneration Committee of the Company, today, on June 13, 2026, approved the allotment of 16,749 equity shares of face value ₹10/- each to eligible employees upon the exercise of vested stock options under the Plan.

The Company had obtained in-principle approvals from BSE Limited and the National Stock Exchange of India Limited on August 31, 2023 for the listing of equity shares arising pursuant to the Plan.

Consequent to the aforesaid allotment, the issued, subscribed and paid-up equity share capital of the Company has increased from ₹2,85,00,00,000 comprising 28,50,00,000 equity shares of face value ₹10/- each to ₹2,85,01,67,490 comprising 28,50,16,749 equity shares of face value ₹10/- each.
